National Ovarian Cancer Coalition Clinical Trial Fund Disclaimer

The National Ovarian Cancer Coalition (NOCC) Clinical Trial Fund provides financial assistance for patients who have been diagnosed with ovarian cancer and are enrolled and participating in an ovarian cancer clinical trial. To qualify for financial assistance from the NOCC Clinical Trial Fund, the patient must (1) have a confirmed diagnosis of ovarian cancer, fallopian tube cancer or peritoneal cancer and (2) be enrolled and participating in a clinical trial for ovarian cancer. The NOCC Clinical Trial Fund offsets non-medical costs which include transportation (airfare, gas, rental car, taxi fare and/or parking/tolls), lodging, and meals/food.

By accepting a grant from the NOCC Clinical Trial Fund, patients attest that they agree to use the grant funds only for eligible expenses. The NOCC Clinical Trial Fund reserves the right to request documentation from patients demonstrating the grant funds have been used appropriately.

Qualifying patients are provided a one-time grant when they are approved for assistance from the NOCC Clinical Trial Fund. The NOCC Clinical Trial Fund is provided on a first-come, first-serve basis to the extent the fund can provide assistance. Enrollment in the NOCC Clinical Trial Fund, and receipt of the one-time grant, is a gift to the enrollee based on the availability of funding and conditioned on the use of the financial assistance for eligible expenses. The National Ovarian Cancer Coalition has no contractual obligation to provide such assistance to qualified enrollees.

Eligibility for assistance from the NOCC Clinical Trial Fund is not dependent on the use of a particular drug, particular supplies, or particular provider or suppliers, and patients are free to switch drug therapies, treating physicians, pharmacies, and suppliers at any time without affecting their continued eligibility for assistance.

The NOCC Clinical Trial Fund reserves the right to request additional information to verify compliance with fund eligibility guidelines. Failure to provide the requested information may result in the closure of the application for assistance. Additionally, if at any time it becomes evident that information has been provided under false pretense, the eligibility process for assistance will be terminated.

Patients' contact information may be used in the future to share printed and/or electronic communications from the National Ovarian Cancer Coalition Financial Assistance Program. If the patient does not wish to receive print and/or electronic communications from the NOCC and/or the NOCC Clinical Trial Fund, he/she may contact the program at 1-866-719-2767 and request to have his/her contact information removed from the mailing list.

Patient data collected through the application process may also be used in de-identified aggregated reports. This means that information and data patients provided to the NOCC Clinical Trial Fund during the enrollment process may be combined with other patients' data to prepare reports analyzing patient needs. The NOCC Clinical Trial Fund will only use de-identified patient data externally, i.e., patient data where all identifying data terms like the patient's name, identifying numbers, etc., have been removed. The NOCC Clinical Trial Fund will always protect all patient information and adhere to the Patient Privacy Policy.
